**RESOLUTION ESTABLISHING AMOUNT OF SPECIAL TAX FOR  
PARKS, RECREATION, AND COMMUNITY FACILITIES FOR  
MOUNTAIN HOUSE COMMUNITY SERVICES DISTRICT**

WHEREAS, this Board, sitting as the Board of Directors of the Mountain House Community Services District, adopted Ordinance 96-3, entitled "An Ordinance of the Board of Directors of the Mountain House Community Services District Establishing a Special Tax for Parks, Recreation, and Community Facilities"; and

WHEREAS, this Board sitting as the Board of Directors of the Mountain House Community Services District, subsequently amended Ordinance 96-3 on September 17, 2002; and

WHEREAS, the Special Tax specified in Ordinance 96-3, as amended (the Ordinance), is subject to passage through an election to be held on December 17, 2002.

NOW, THEREFORE, BE IT RESOLVED, provided that the amendment to Ordinance 96-3 is approved by the voters on December 17, 2002, this Board, pursuant to Section 2 of the Ordinance, hereby establishes the amount of the Special Tax pursuant to Section 3 of the Ordinance, at the following:

Developed Land. \$1.80 per one hundred square feet or fraction thereof of the area within the living area of residential buildings and the total area within non-residential buildings or other structures. \$0.36 per one hundred square feet or fraction thereof of parcel area for non-residential parcels and for residential parcels under 6,000 square feet. \$0.06 per one hundred square feet or fraction thereof for residential parcels equal to or greater than 6,000 square feet.
